Those presenters chosen will be asked to bring enough handouts for session attendees if handouts are desired and to provide us with an electronic version if their presentations/handouts two weeks prior to the convention. Submission of a proposal for a presentation will serve as authorization for CAPA to post any session content on the CAPA website for future reference by members. Presenters are expected to register for the convention at the established rates.

Deadline to submit: June 1, 2019.

Proposals received after this date will be considered on a space-available basis only. Proposals will be reviewed by the program committee and selected upon the criteria of overall quality, originality and appropriateness to this program. All potential presenters will be notified of proposal status by July 15, 2019. Those chosen will receive presenter information/details shortly after they are confirmed.

Sample topic areas include but are not limited to:

- Authentication - watches, handbags and more
- Dealing with coins or diamonds
- Financial / ROI and investments
- Future trends and resources
- Regulations and how they impact the industry
- Selling - psychology, tips and trends and more
